LOCAL PLAN ENOURY

he Society made 12 appearances at the Borough Local Plan Examination in Public, which concluded on 15th December after the inspector had called for an additional session, so that the Borough could provide upto-date evidence to support its housing land supply figures. The new material submitted by the council still demonstrated a very substantial surplus of land to be allocated for development as against the assessed need. This continued to underpin our claim that it is unnecessary for the Borough to allocate large areas of land for house building in Cookham.

We also took issue with the Borough's changes to Green Belt policy which, we said, would down-grade the protection currently afforded to the Dean by allowing infilling on a seemingly ad-hoc basis, at the whim of individual planning officers.

The inspector had already carried out some of her inspections before Christmas and we hope she was able to appreciate the traffic and safety difficulties we

experience daily in The Pound and at Cookham Bridge. We now await her report and recommendations.

BATTLEMEAD COMMON

The Society were delighted when in 2018, the Borough decided to buy part of White Place Farm to create a new area of Public Open Space. Consequently, we have been active members of Friends of Battlemead Common, the organization set up by the Borough as a forum to discuss how to serve the sometimes, differing priorities of residents and of other local organizations, for the site. The Borough is under pressure to make sure that any decision about the Common strikes the right balance between the need to protect important wildlife and habitats, whilst keeping as much of the space open to ramblers and dog walkers as possible. Even such an apparently simple idea as providing a carpark is difficult because of differing views about the size and siting of the

plan. At present, there is only one, all-year footpath available between the entrance on Sutton Road and the river. We are continuing to press hard for a second path at the south of the site, so that there is



an attractive circular route taking in this beautiful section of the Thames Path. Additionally, after a sustained and loud drum beat from the Society, the Borough has been persuaded to prepare a Hydrological Management Plan for the Common to address future flooding issues that directly affect Cookham when water levels are very Dick Scarff

NEIGHBOURHOOD PLAN

In June 2020, RBWM designated Cookham a Neighbourhood area and after a number of exploratory meetings, a working party was set up on 7th July 2020. Led by Cllr Bill Perry, the group began the process of scoping the plan and consulting as many local statutory and voluntary organizations, businesses and interested parties, as possible. The Society has been fully involved from the outset.

Cllr Bill Perry said that his key objective was to "To make sure that we consult very widely from the start and that we ensure that the whole process is fully transparent". All the papers can be seen on the Parish Council's website and public consultation starts in February.

OFFICERS' REPORTS FOR 2020

CHAIRMAN

Despite all the difficulties caused by Covid-19, the Society had a busy year although, regrettably, we were not able to meet any of our members at public events. I am pleased to report that prudent housekeeping and generous on-going annual contributions from people renewing their memberships, enabled us to report a financial surplus for the year. We are very grateful for your continued support. New technology has enabled us to carry on business almost as normal, with virtual meetings for our committee and its Planning and Environment Sub-committee which, because of changes at the Borough, has been required to meet on a fortnightly basis. I should like to take this opportunity to thank all my colleagues for their support during my Chairmanship.

CHAIR OF PLANNING AND ENVIRONMENT COMMITTEE

Planning: We continued to monitor all planning applications in our area and meetings of the Planning and Environment committee were held over Zoom. The committee meets every two weeks to keep in step with the timescales set by the Borough for comment and for call-in to Panel. 2020 saw a total of 226 planning applications, which is a small increase on the previous year. We submitted objections to 29 applications and a further objection to one refused application, that subsequently went to appeal. Additionally, we have spoken at two remote Development Management Panels this year.

An especially unwelcome application was submitted for a large development of flats at the Old Station Yard. We have objected strongly to this and are awaiting a Panel hearing. Following last year's application for a new pavilion for the cricket club at Whyteladyes Lane, an application for a new football club pavilion has been submitted at a site in Long Lane. If these go ahead, our local sports clubs could enjoy improved facilities.

We continue to be disappointed by the Borough's lack of progress with the revised Conservation Area Appraisal for Cookham Village.

The Society has made initial policy suggestions to the now, live, Cookham Neighbourhood Plan process and expects to make further submissions in due course.

Environment: Following pressure from the Society, the Borough has agreed to develop a Hydrological Management Plan for Battlemead Common.

We are pleased to report that the track and bridge just north of Strand Water that were reopened last year as a Permissive Path, have now been made into a Right of Way. This forms a small, but useful addition to our footpath network.

The beginning of this month saw the worst flooding in Cookham since 2014 with both the Moor and Ferry Road closed to traffic. Thankfully, at the time of writing, water levels appear to be dropping back a little. If all three roads into Cookham village become impassable. RBWM will open the Causeway for cars and light vehicles in line with the procedure agreed with us after the 2014 floods.

Whatever happens in the present flood event, we will continue to monitor and if necessary, challenge the Environment Agency, Thames Water and RBWM in order to protect and improve Cookham's flood resilience.

We continue our involvement with the Marsh Meadow Management Committee, the Cookham Advisory Committee of the National Trust and we maintain our memberships of the Maidenhead and Marlow Passenger Association, the Heathrow Association for the Control of Aircraft Noise and the Open Space Society.
