There have been few contentious planning applications during the last six months: many people are extending their homes, a large number of trees need to be cut down or reduced and some "reserved matters" in old planning applications have come up for approval.

Probably the most disputed application has been the proposed extension of Spencer pub. The new owners, Greene King, wanted to extend the kitchen and dining areas an turn the pub into a Brubeckers Restaurant. It was felt that the extension would make the pub too large and would impinge on the neighbours. Also the enlarged pub would probably attract more customers and the extension would reduce the number of available parking spaces. In view of the objections, the brewery withdrew their application and decided to promote the existing restaurant as part of their fine dining country pub chain. There will be a further application to extend and improve the existing facilities but nothing as obtrusive as the original proposal.

A great deal of effort has gone into work on preparation of the Village Plan. It had been hoped to be able to complete the work before the holiday season but several factors prevented this. It is now hoped that the completed Plan will be presented to the Parish Council in the next two months. The Plan will undoubtedly contain recommendations which may not be to everyone's liking but "you cannot please all the people all the time". In order for the Plan to be incorporated into the policies of the Local Development Framework (Local Plan to you and me), further work will be needed to draft a Village Design Statement which should be used to give the Borough planners guidance as to what sort of development would be acceptable to the community and where it should be allowed. The Society will certainly be asked to assist with this task and volunteers to contribute will be welcome.

As soon as the Plan has been presented to the Parish Council, it will be available for all to study on the Cookham.com web site with hard copies in the Library and Parish Office.

Footpath 60

The long-running saga of Footpath 60 which has been blocked from running beneath Cookham Bridge, from the Bourne End side to the Ferry Inn terrace has finally ended.

The problem for very many years has been the ownership of the towpath alongside Ferry Cottage. Not only were the mooring rights involved but also the actual ownership of the towpath itself.

Resolved they were, thanks to the persistence of stalwarts like Margaret Bowdery of the Ramblers Association but also the skills of the Rights of Way Officers in The Royal Borough.

Because of natural obstructions on the Ferry Inn side of the bridge, such as embedded iron work together with a massive tree root growth it was considered a more realistic solution to install a graded "boardwalk" of about five feet in width to rise above the obstructions to land on the terrace of the Ferry Inn.

On the 21st August a large party of 4 wheel "Scooters" were the first disabled to cross over the boardwalk and really bring it all to life. The party of some fifteen "scooters" were headed "Quod erat Faciendum" by Dr. Mike Bruton of "Disabled Ramblers"

Environmental Enhancement

All this is exactly what the Cookham Society's constitution stands for - the preservation and enhancement of our Village. And this is something **positive** – a change from the usual run of having to raise objections to planning applications!

Polytunnels

Some comments have been received lately about *Polytunnels* which have appeared recently (not only at Lower Mount Farm.) The position regarding the need for planning permission for *Polytunnels* is not entirely clear. There has been at least one High Court judgment stating that planning permission is required but it also stated that each application should be judged on its merits. Factors to be taken into considering include the visual impact of the *Polvtunnels* in the location, permanence of the construction (if the supporting frame is set in concrete it is regarded as requiring planning permission whereas if it is merely pinned to the ground it does not) and whether the siting and use conform to NFU guidelines. We should monitor the situation and check the types of *Polytunnel* being used.
