## Transfer of with-profits annuity policies to Prudential

## Extraordinary General Meeting - your vote counts

In March 2007 Equitable Life entered into an agreement to allow all Equitable Life's withprofits annuity policies (representing about 20% of the with-profits fund) to transfer to The Prudential Assurance Company Limited (Prudential).

The transfer is subject to the sanction of the High Court and to the approval of Equitable Life's members. We are seeking members' approval at an Extraordinary General Meeting (EGM) of Equitable Life which will take place at Church House Conference Centre, Westminster, London SW1P 3NZ on 26 October 2007 beginning at 11.00 am. I encourage you to vote on the resolution set out on the attached voting form, even if you cannot attend the EGM.

Your Board unanimously recommends that you vote FOR the resolution.

We unanimously recommend that you vote for the resolution because the Prudential will put your with-profits annuity policy(ies) into an actively managed fund which is one of the largest and strongest in the UK and which has greater bonus earning potential than the current Equitable Life fund, although increases to bonuses are not guaranteed.

Subject to members' approval and the sanction of the High Court, the transfer is expected to happen on 31 December 2007.

Please use your vote. Without the approval of the voting members of Equitable Life the transfer of with-profits annuity policies to Prudential cannot proceed. Your Board is of the clear view that failing to approve the transfer would be to the disadvantage of ALL policyholders.
